## 1. General description

The 74HC03; 74HCT03 is a quad 2-input NAND gate with open-drain outputs. Inputs include clamp diodes that enable the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .

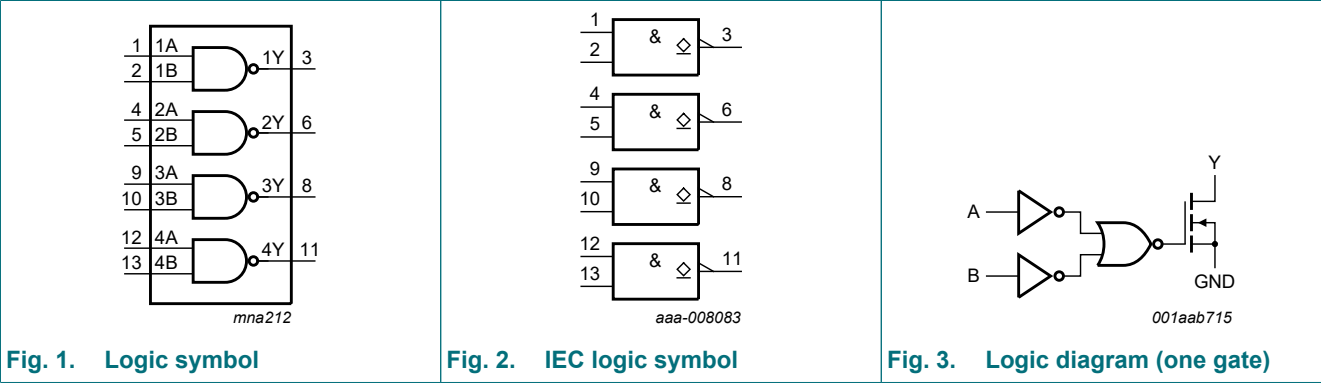

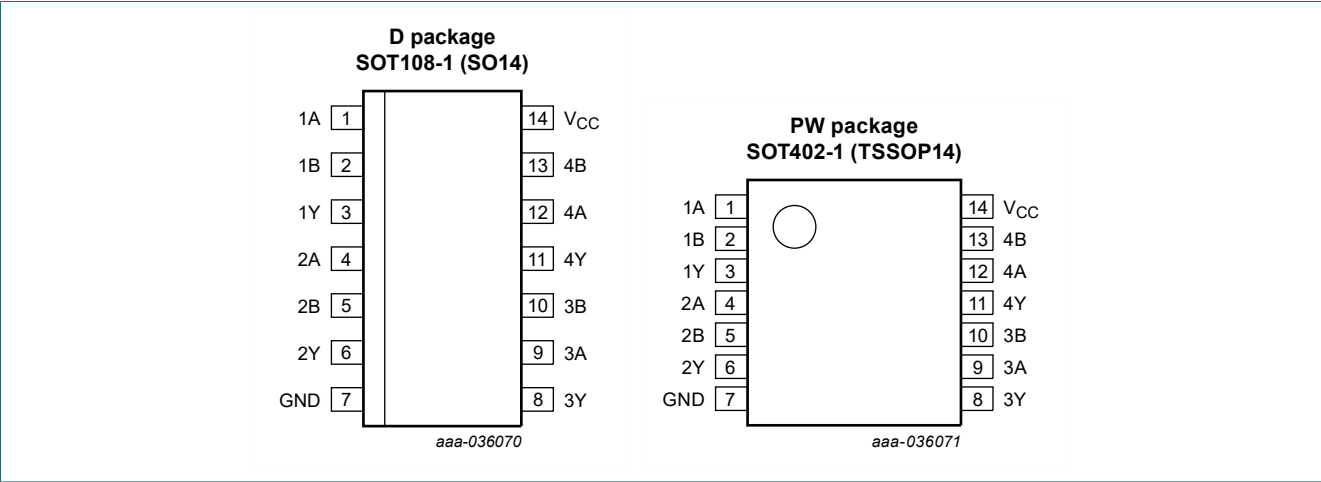

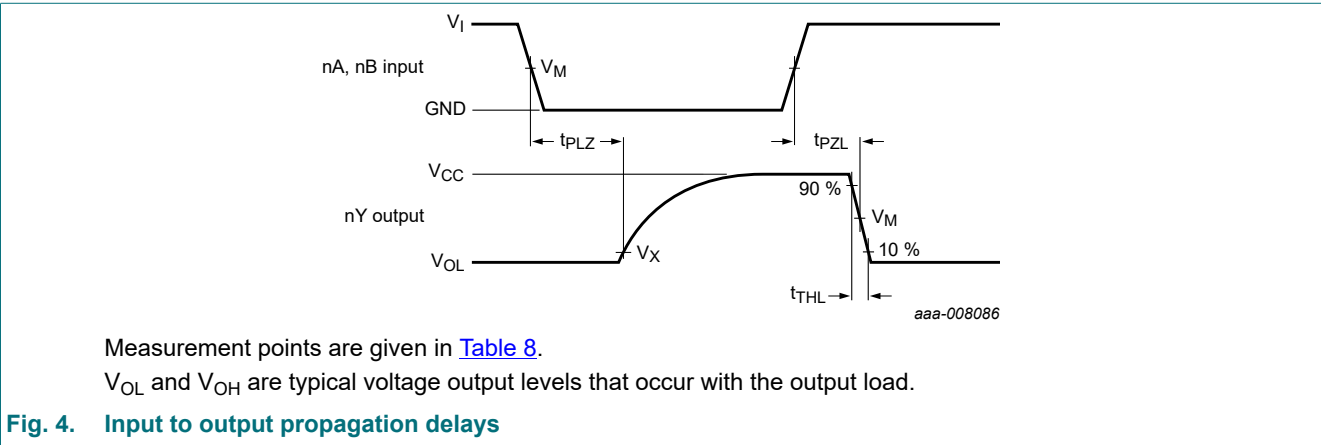

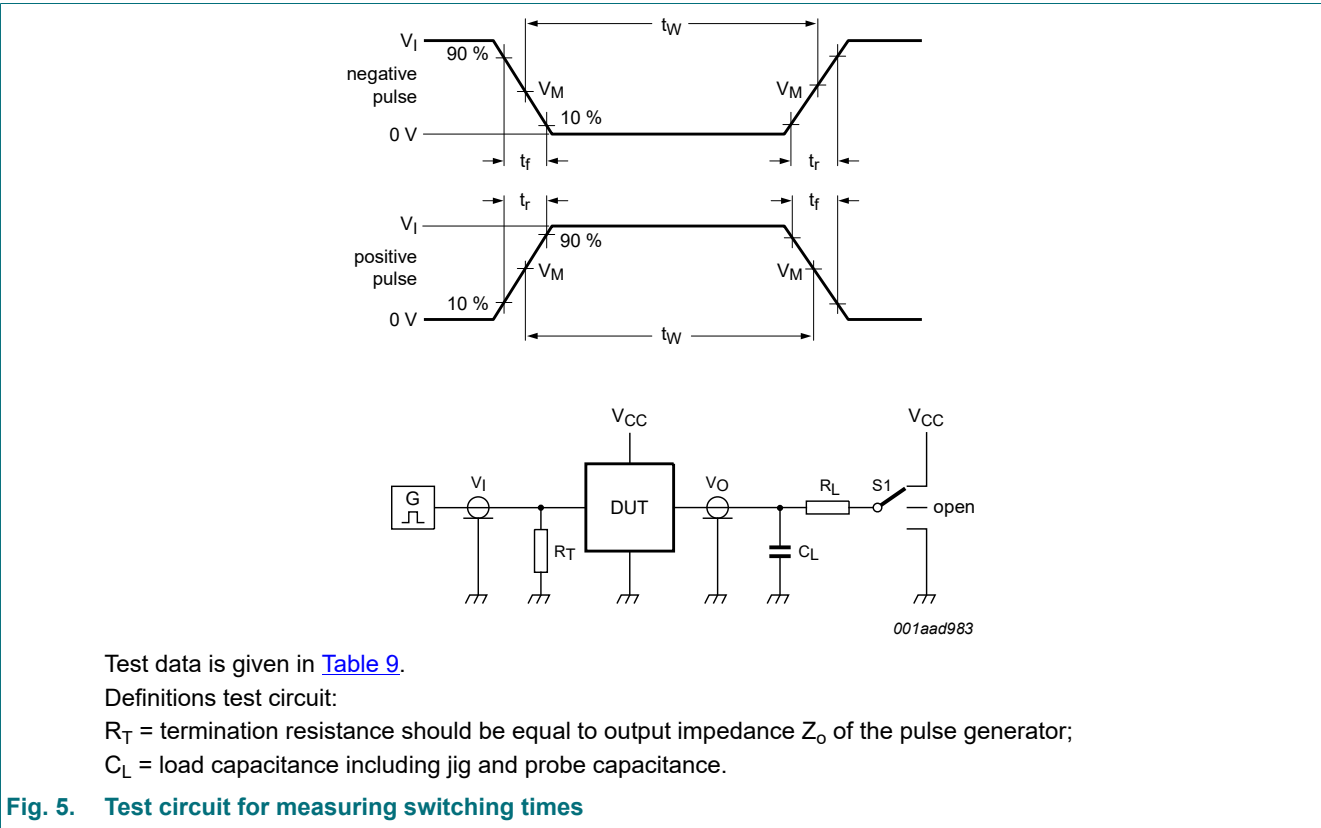

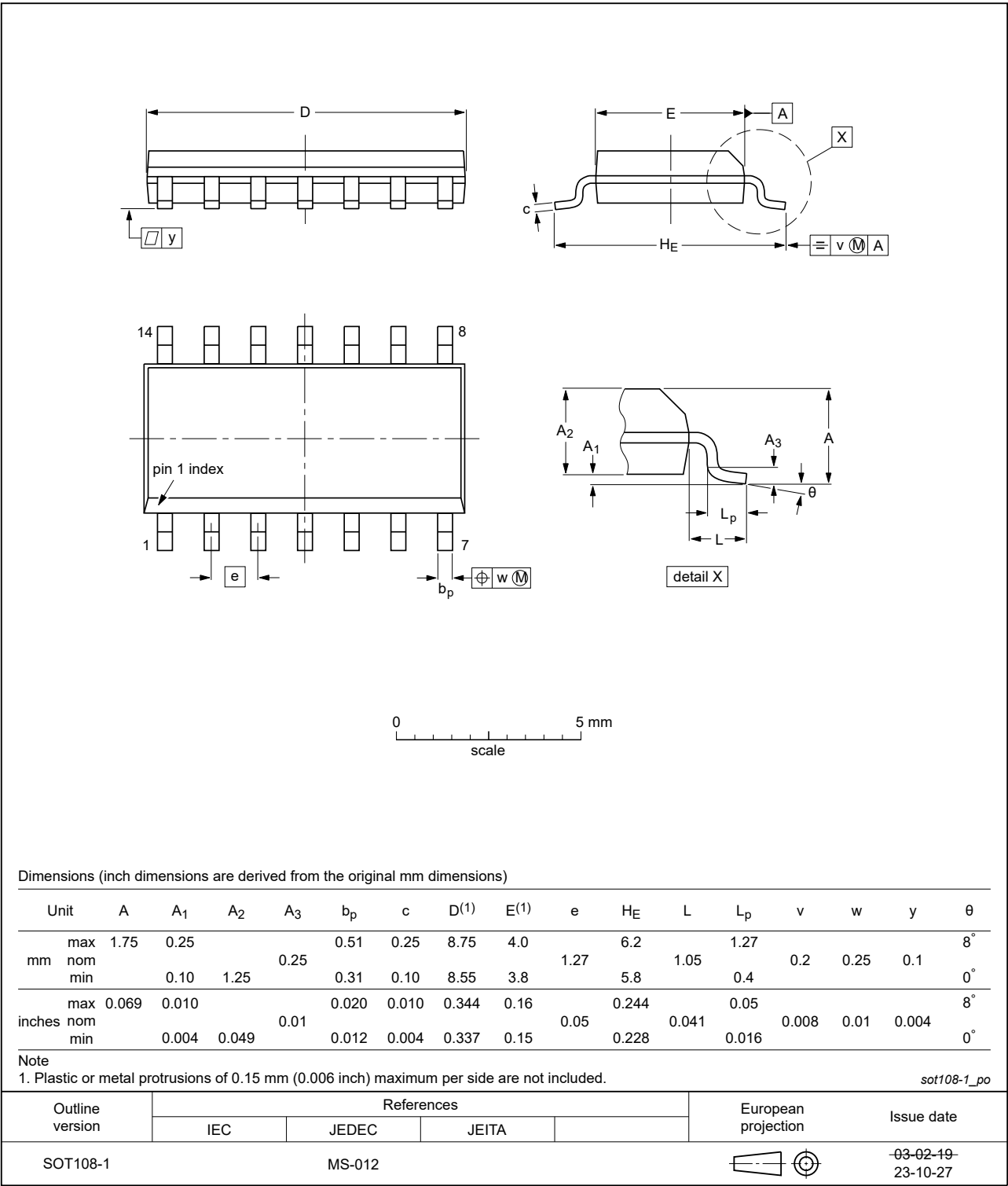


Fig. 6. Package outline SOT108-1 (SO14)

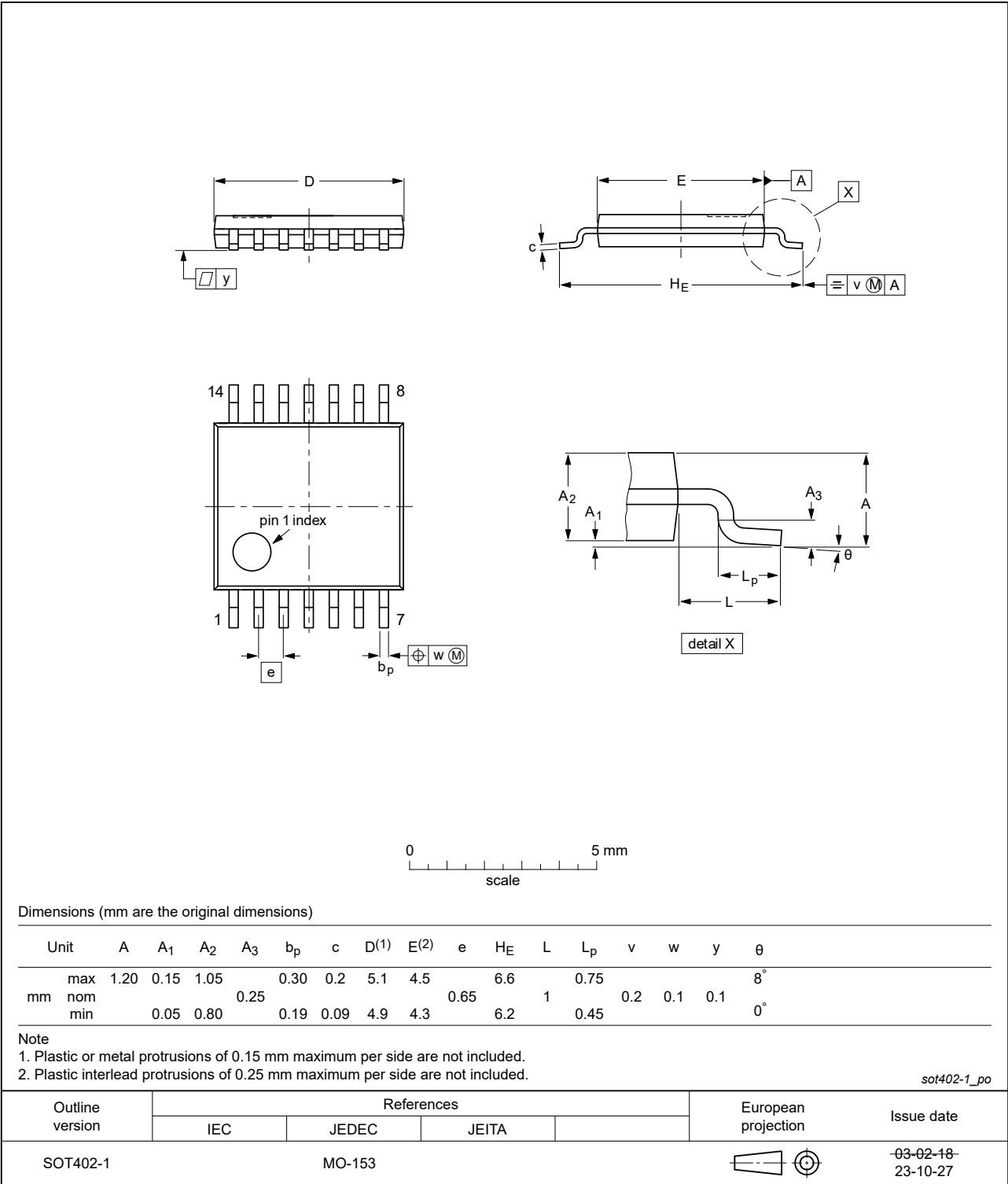


Fig. 7. Package outline SOT402-1 (TSSOP14)
